  4. Merge onto OR-126 E. (1.04 mi)

  6. Turn LEFT onto MOHAWK BLVD. (0.23 mi)
  7. Turn RIGHT onto MARCOLA RD. (11.36 mi)
  8. Turn LEFT onto CARSON ST. (0.02 mi)
  9. End at Marcola, OR US

**Know Before You Go**

Member **Mike Wolfe** discovered recently that not all Oregon State Parks are open to detecting; and if they are, not all areas within the park are open.

Mike had planned a trip to the coast, taking his detector along. Once there, he discovered that the only detecting allowed in the state-run parks between Newport and Wald-

port—where he was staying—was on the beach. There was no detecting allowed within any of the parks with regard to picnic areas or campgrounds.

Mike also discovered that the North Coast district office for the State Parks had moved to Newport from Lincoln City. He notes this new address: 401 SW 9th Street, about a mile or so from the north end of the Yaquina Bay bridge. ❖
